With the support of thousands of donors and volunteers, United Way of Central Ohio partners with local nonprofits to provide critical basic needs that help families thrive.

# WE'RE BUILDING A STRONGER, MORE EQUITABLE CENTRAL OHIO.

### **Success by Third Grade:**

Network directors began working in the Columbus City, Groveport Madison and Whitehall school districts, establishing relationships with community leaders, educators and families as they identify and address barriers to student success. Highlights from 2022 include Whitehall's summer literacy program, Groveport Madison's Reading Buddy program and the donation of 2,300 new winter coats to Columbus City Schools elementary students.



### Mobilizing the caring power of the community:



United for Impact took place in May 2022, raising over \$650,000 for 74 nonprofit partners, thanks to the generosity of our donors and corporate sponsors.

Our Stuff the Backpack event, in partnership with NBC4 and the Columbus Crew, brought together hundreds of volunteers to stuff backpacks at Lower.com Field in August.

## WE HELP STUDENTS SUCCI

Our investments in effective local nonprofits ensure children have equitable opportunities from cradle to career.

### Last year, our Community Response Fund:



Invested \$3.9 million to provide 63 grants to 52 funded nonprofits

Served 36,609 students through 44 programs

90% of children improved on Get Ready to Read **BC** assessments, demonstrating they were ready for kindergarten

95% of students improved or maintained literacy fluency



### A trusted partner for 100 years:

With an eye toward community issues, we selected Columbus Metropolitan Housing Authority and national nonprofit The Community Builders in September to redevelop our former headquarters at 360 South Third Street into much-needed, mixed-income housing.

Thanks to Nationwide, we moved to the Community Impact Center in December with other nonprofits, forming a hub that features efficiencies of scale and ongoing collaboration to maximize impact when addressing critical needs.

#### One Linden Schools Initiative -

Started in 2017, the One Linden Schools Initiative is a multi-tiered approach to student success focused on student and teacher relationships and behavior, as well as parental and community engagement. As teachers and students have become more connected, office discipline referrals have decreased by 60%.

Students with high numbers of conflicts and discipline events showed marked improvement:

100% advanced to the next grade 86% improved or maintained behavior 100% improved social emotional learning

The initiative is a partnership among Columbus City Schools, the City of Columbus, United Way of Central Ohio, The Ohio State University and others.

Cesar's favorite thing about the Boys & Girls Club of Central Ohio is playing games with his friends. His dad says the Club opened up a world of opportunities for his son. When he started first grade, Cesar had significant communication barriers. But with patience and guidance from the Club's staff, he has developed a sense of belonging and gained confidence. Cesar's behavior and academic skills continue to show great improvement.
