

Franklin County Columbus Counts: 2020 Census Grants

Franklin County Grant Application

Funding Opportunity: The Franklin County Board of Commissioners is providing funding to support local, community-based organizations in getting out the 2020 Census count in Columbus and Franklin County. The Commissioners' goal is to ensure every resident in Franklin County is counted, **especially individuals from traditionally hard-to-count (HTC) communities**. This funding will be distributed to local community-based organizations in Franklin County through a mini-grant process for the purpose of reaching traditionally HTC communities. Each local organization will receive a grant to implement Census activities that educate and organize their HTC communities around the Census.

Background: Every ten years the federal government is required by the U.S. Constitution to conduct a headcount of every person (not just citizens) living in the country. In March 2019 Franklin County Commissioner Kevin L. Boyce and Mayor Andrew J. Ginther jointly founded *Columbus Counts*, our community's Complete Count Committee to ensure an accurate 2020 Census count. A diverse group of community, business, non-profit, and government leaders work on Columbus Counts to promote the 2020 Census, its importance to our community, and motivate residents to self-respond to the census.

Census Timeline: The official 2020 Census Day is on April 1, 2020, however, residents can begin responding in March 2020. The Census Bureau will count residents through an undetermined date in the summer of 2020. Funded grant partners will be expected to focus on one or both of the two following phases:

1. Census Education and Awareness Phase: February 2020 to April 1, 2020
2. Get Out The Count or Motivation Phase: early April to summer 2020*

*Phase 2 will include limited census education but should focus on Get Out The Count efforts

**Attached is a detailed 2020 Census Timeline

Eligibility:

- Applicant organization is to be a local community organization (non-profits are preferred; for profit entities with significant community engagement experience will be considered on a case by case basis).
- One proposal is permitted per applicant organization.
- The program accepts grant requests up to \$10,000.
- No match is required.

Project Types:

Proposed projects must promote 2020 Census awareness and motivate residents of hard-to-count (HTC) communities to self-respond online to the Census. **Proposals will not include official Census Bureau work counting residents. Only sworn Census Bureau employees can conduct the actual count.** These project proposals are only for **awareness, education, and motivation** for residents to participate in the Census Count.

Below are examples of the types of projects that could qualify. This list should be used as a guide. Applicants are encouraged to propose innovative projects to engage their respective HTC communities. Proposed projects are **not** limited to these examples:

- Culturally informed events with Columbus Counts branded materials including translation into Somali, Spanish, Nepali, Bhutanese, and other critical languages
 - MLK Day, President's Day, Memorial Day, Black History Month, Ramadan, etc.
- [Census kiosks](#) (Columbus Counts-branded laptops, iPads, desktop stations for residents to complete the census)
- [Mobile hotspots with Wi-Fi](#) (digital census hubs where residents gather like churches, barbershops, community centers, Head Start sites, etc.)
- [Columbus Counts Ambassador Program](#): conduct citywide training at different locations of hundreds of volunteers to be certified ambassadors in their communities, including trainings in other languages
- Canvassers or street teams to promote census
- Transportation for residents, especially for those with limited internet access or disabilities, to complete the census at a census hub or other public location (i.e. bus passes to library)
- Speakers Bureau: train and motivate neighborhood leaders to be census advocates
- Supplies: such as census children's books for ages 0-5
- Digital Equity Grants (could be modeled after [Philadelphia example](#))
- Small Business Partnership Program (small businesses participate and share census information with customers and employees; decals on shop windows, etc.)
- Census Jobs Fair: the Census Bureau needs help hiring thousands of residents from the community to help conduct the count.
